Pledge of Allegiance

Michael Moake, Davis County Legacy Events Center Marketing, led the Pledge of Allegiance. All in attendance were invited to stand and join in.

DC Attorney's Office employee commendations

Troy Rawlings, Davis County Attorney, has been invited by Measures for Justice to make three presentations nationally (not at taxpayers' expense). Measures for Justice did a statistical analysis across the country of district and city attorney prosecutors' offices on nine different measures of performance that they felt were important; i.e. how many cases you screen get dismissed, how many are pled down, how long do they take, how many motions to compel evidence do defense attorneys have to file against the prosecutor's office. Statistically, they determined that the Davis County Attorney's Office ranked as one of the top four in the country. He credits having hired the right people. He introduced prosecutors Nathan Lyon (hired in 2011) and Jeff Thompson (hired in 2016). He likened them to the MVPs (Most Valuable Players) of his office saying that they handle some of the most difficult and complicated cases (murder, etc.). Troy invited both Nathan and Jeff to speak to a couple of their most serious cases. Troy noted that it is extremely important that the documentation for the cases be handled timely and thoroughly, which both Nathan and Jeff accomplish. Troy felt that they both have a future in the legal profession for anything they want to do, including being judges. Because of the nature of what the prosecutors do, they don't get the recognition that they deserve.

The Commissioners extended their sincere appreciation to Nathan Lyon and Jeff Thompson for the stellar work they perform. They also recognized Troy for his leadership. Nathan and Jeff were presented with a commemorative Davis County coin within a State of Utah display. Pictures were taken to memorialize the commendations.

Notice of Special Meeting for a Public Hearing regarding Davis County's proposed 2018 Budget will be held tonight, December 5, 2017 at 6 PM here at the Davis County Administration Building, room 303. Commissioner Smith invited the public to come and share their thoughts and observations as they consider the proposed budget.

Public auction for the sale of DC surplus real property Tax ID 11-111-0072 (925 E 200 N, Kaysville)

Commissioner Smith read the following in regards to the public auction of Davis County surplus real property:

We are about to begin the public auction process for the Sale of Davis County surplus real property in accordance with Chapter 2, Section 42 of the Davis County Code. We are asking the people who are interested in bidding on the surplus property to please fill out the Pre-registration form and get a placard to use when making a bid.

Now is the appointed and advertised time at which the County will offer for sale surplus real property located at approximately 926 East 200 North, Kaysville, Utah, is identified as tax parcel number 11-111-0072, and contains approximately 0.45 acres. The property being offered for sale is depicted on the map that is on the screens. The Board of County Commissioners has set the minimum price for the surplus real property at \$64,243.00.

Once the County has closed the sale of property as a result of accepting a bid on the parcel, the successful bidder or purchaser of the property may not unilaterally rescind the bid. The county legislative body, after acceptance of a bid, may enforce the terms of the bid by obtaining a legal judgment against the purchaser in the amount of the bid plus interest and attorney's fees. The only acceptable methods of payment to the Davis County Treasurer for the property purchased shall be in cash, certified check, or money order. Funds must be presented in person and concluded before 5:00 p.m. on the same day of award of bid. **Payment will be accepted at the Treasurer's office on the 1<sup>st</sup> floor, Room 105.**

Keep in mind that today's sale is a "**buyer beware**" sale. If you purchase property today you will later be provided with a quit claim deed. Accordingly, it is your obligation as the purchaser to have researched each property. We hope you have done your research before coming today as **all sales are final.**

Property sold today shall be conveyed by Quit Claim Deed. This form of deed is not a warranty deed. The County makes no representations or warranties as to whether the property is accessible, buildable or developable, nor does the County make any representations or warranties regarding whether the property complies with applicable zoning regulations. The County does not warrant or represent that the property purchased is habitable, buildable, or in any particular condition. The County also makes no warranties or representations regarding the accuracy of the description of the real estate or improvements thereon. Access to properties on the sale is not guaranteed.

At the end of the bid I will ask the Highest Bidder to state their Name and the amount of the bid.

Commissioner Millburn made a motion to approve contingent on the appropriate budget change which is slated for the December 12, 2017 budget opening of the 2017 Budget. Curtis Koch anticipated the budget change would be approved during the budget opening, but indicated that the State Auditor's Office has given specific guidance not to spend money before it is in the budget. The money is in fund balance, in reserve, for this purpose. Curtis requested that his office be included in the discussion earlier in the process.

Commissioner Millburn amended his motion to approve contingent on the funds being made available before UDOT sets a closing date. Commissioner Elliott seconded the motion. All voted aye. The document is on file in the office of the Davis County Clerk/Auditor.

Commissioner Millburn reiterated to keep the lines of communication open. Curtis added that in 2016 they used Corridor Preservation funds as alternate liquidity to help our cash flow. They opted not to use that this year, hence they went out for TANS. Even with other funds, i.e. Tourism & Capital projects they are

potentially being used as cash reserves to make payroll. Tony indicated that UDOT had the urgency to close the purchases by the end of the year. He and his department want to work within the budget process.

Request #2017-411B approval to utilize Davis County Corridor Preservation Funds, as recommended by the Davis County Council of Governments, for the advanced acquisition of 45 acres of the Lynn and Laura Stoddard property (Tax ID 08-081-0035 in Farmington) for the West Davis Corridor through the Utah Department of Transportation. Tony indicated that there is one situation where Woodside Homes is working with Farmington City on the property north of it for a subdivision. If that happens, it may not be the full 45 acres required and would reduce the sale. If Woodside doesn't get the subdivision, it would landlock the parcel and UDOT would be required to take the whole 45 acres. The price may adjust to be lower. The payable amount is \$4,449,100.00 + closing fees.

Chris Sanford, Davis County Library Director, felt the selection committee process was a good thoughtful process. They're confident and excited to get moving on the project. Commissioner Millburn noted that this was informational and that the action will be taken once the contract is brought forward. Neal Geddes noted that this notice through the new RFP policy is to put it on public record and that this entity was ranked the highest and we will pursue a contract with them. It begins the protest time period.

Commissioner Smith felt that this meeting was a good demonstration of how varied and frequently challenging this job can be; from vintage treasures, to selling property, to making million dollar transactions to help with transportation and recognizing our County Attorney's and excellent employees. He gave encouragement to the public to come to tonight's public hearing at 6 PM.

Commissioner Millburn echoed Commissioner Smith's comments and added the adjective "complexities". He felt it was very beneficial to recognize key employees and to hear more in-depth information of what issues and services our employees are providing to our citizens. He thought that would be the case in each department. "Davis County really has some all-stars." It is not boring. He thinks that County government is the least understood or almost forgotten level of government, but we probably touch citizens' daily life more than other level to some degree.

Commissioner Elliott also echoed the comments. Hearing his wife's book on tape, "What Makes Good Companies Great Companies" the author and his investigators did their research and determined that it was the CEO and their team that made good companies great. He sees that here in Davis County with our staff and directors. "They are great people we have who are making great efforts in the County." He noted that the parcels that were being sold today made him a bit emotional. Even though there is progress on the highway, they are properties that he grew up on (family leased) that gave him the work ethic that he has now.

Neal Geddes also gave commendation to the prosecutors, Nate (Nathan) and Jeff, "who do a great job." He noted that we often forget as we go through our daily work tasks dealing with one another and get stressed trying to complete projects on time. "They, daily, are dealing with life and death, very serious situations and other heinous crimes and the emotional toll it takes on them." He expressed his appreciation to not only them, but to the other wonderful prosecutors they have in their office as well.
