## Emotional Support Animals (ESA)

Do you want to register your pet as an Emotional Support Animal? Read about the [Fair Housing Act](#) (FHA) and what rights you may have under the law. Please note the only thing required to have your companion animal certified as an ESA is a letter from a physician, mental health service provider, or other medical provider. Almost all of the registries and websites online are fraudulent and your landlord may deny these forms.

**We are aware of two legitimate websites to obtain an ESA letter, where you will speak with a licensed therapist via a telephone interview:**

Your landlord cannot require additional paperwork, to speak with your doctor, or require anything other than the letter required by law. See the [differences](#) between ESAs, Service Animals, and Therapy Animals.

If you received an eviction notice related to having pets in your home, you can contact [Utah Legal Services](#) who may be able to represent you at your eviction hearing.
