Discussion of Proposed Lease Agreement Between Davis County and Rock Hotel Dental, LLC and Related Issues (Minute 01:00)

Dr. Corry said he was here on behalf of the dentists at Rock Hotel Dental. The County has had a parking agreement in place with Rock Hotel Dental since its building occupation. The most recent contract with Rock Hotel Dental leased 23 parking spaces to them but has since expired, and the County has not accepted payment for the last two years. It was conveyed to the County that the Dentists would be moving to another location. The County is under increased pressure to have sufficient parking available to its employees and understood there would be a sunset on the parking agreement to take back those parking stalls for their employees to utilize. With this understanding in mind, the County drew up a new lease that would expire on December 31, 2026 (including the optional two-year extension), after which there would be no more parking options for them. Rock Hotel Dental has still not signed the new lease since the County sent it several months ago.

Dr. Corry clarified that several dentists are planning on opening a second location. However, they are not relocating the business and would still need parking beyond the end of the contract. The County said it is not feasible to continue offering its parking stalls to them.

Dr. Corry understands that the contract needs to be signed, first and foremost. Then they need to figure out how to acquire the parking they need to conduct their business, and that the County can't make any guarantee that they can offer any spaces once the contract expires. From now on, Dr. Corry agreed to be the spokesperson for the dentists.

CLOSED SESSION—Commissioner Kamalu moved to a closed session for reasons permitted under UTA §52-4-205(1)(c) reasons to discuss pending or reasonably imminent litigation, and/or (1)(d) strategy sessions to discuss the purchase, exchange, or lease of real property, including any form of a water right or water shares. Commissioner Stevenson seconded the motion, and all voted aye.
