### WORK SESSION DISCUSSION

**Porter-Walton Community Reinvestment Area (CRA)**—Presented by Rob Sant, Vice-President, Lewis Young Robertson & Burningham, Inc. (*Minute 00:57*)

Rob said the Project Area Plan and Budget was proposed to the Economic Development Committee in February of this year and was approved to move forward to present the Porter-Walton CRA project to the Commission. It is located east of I-15 and south of 400 South, along the Frontage Road. Centerville City approached the Young Automotive Group about reinvesting in the area and developing a Power Sports Automall. The plan is to build an 80,000 square foot building totaling \$17,179,558 for the assessed value. The current value of the land is \$6 million. Rob asked for a 15-year tax increment participation at 50%, which will create 60 new jobs with an average wage of \$52,000. This project is a unique concept and will ideally house seven different brands inside the complex and likely draw customers from around the region.

Centerville City has already signed their interlocal agreement, and in two weeks, they will be meeting with the School District to begin negotiations once the new superintendent is in place. They also have meetings scheduled with three of the special service districts.

# COMMISSIONERS' MINUTES – DAVIS COUNTY

Currently, the County receives \$10,668 in annual property tax, and in 15 years, that will go up to \$160,000. The 50 percent of TIF gives the County an additional \$11,170 per year and, in 15 years, an additional \$167,544. Rob explained the estimated uses of the tax increment. The net benefit to the taxing entities is \$8.8 million, with \$2.4 going to the County and \$48,000 to the Library.

Kent Andersen said the next step is for the Commission to approve the interlocal agreement. It will be on the agenda for the next Commission meeting in two weeks.
