^{*} Obligations for services exceeding one hundred eighty-three (183) hours on a project exceeding five million dollars (\$5,000,000.00) in value shall be paid by the person, entity, or otherwise who is issued a building permit by Davis County (the "Permittee") within thirty (30) calendar days after Davis County mails Permittee an invoice for these services. Depending on

the scope of a particular project, Davis County may send the Permittee several invoices that shall be timely paid by Permittee. If a Permittee fails to timely pay for services in excess of one hundred eighty-three (183) hours, Davis County may, in the sole discretion of the Davis County legislative body, impose a penalty of up to five (5) percent on the delinquent amount and may, in the sole discretion of the Davis County legislative body, also require the Permittee to pay interest on the delinquent amount from the date of delinquency until paid in full at a rate up to ten (10) percent per annum.
