



2024 NOTICE OF FUNDING OPPORTUNITY

Davis County Community and Economic Development will soon be accepting applications for the Community Development Block Grant (CDBG) and Social Services Block Grant for our upcoming program year that will begin on July 1, 2024.

Required Training: A required training will be held on December 14, 2023 from 12:00pm – 1:00pm in the Davis County Administration Building located at 61 S. Main Street, Farmington, UT 84025 Rm 306. All applicants interested in applying will need to attend in-person or virtually. Eligibility: Non-profit agencies, non-entitlement cities, quasi-government agencies, and County departments located in Davis County and/or serving Davis County residents are eligible to apply. Organizations/Projects located in Layton or Clearfield are ineligible unless serving the greater Davis County community.

Project Types

Community Development Block Grant (CDBG) (Housing, Public Facility, and Infrastructure Improvements)

Funds will be used to support housing choices through home improvement programs, homeownership, land acquisition for affordable housing development; neighborhood revitalization and improvements to infrastructure or public facilities.

Community and Social Service Programs (CDBG Public Services and Social Services Block Grant {SSBG})

Funds will be used to increase education, support case management, educational & training opportunities, and foster healthier families by addressing the identified basic needs as well as fundamental housing, food, health, and safety concerns.

Income Qualifications and Service Area: CDBG recipients must provide activities that serve clients at or below 80% AMI, who live in the “Urban County” area, (excluding Layton and Clearfield who receive their own CDBG allocation). Income thresholds will be distributed when release in April 2024.

Minimum Funding Requests and Application Period

Community Development Block Grant	Housing, Public Facility, Infrastructure:	\$50,000
Community and Social Services	CDBG Public Services and SSBG:	\$25,000

The [Neighborhoodly application portal](#) will open on January 8, 2024 and close on February 11, 2024 at 11:59pm. All applications will need complete project descriptions (photos if applicable) including how the project will serve individuals at 80% AMI OR project maps detailing that the project occurs in a qualified census tract. CDBG funding must comply with priorities of the [Davis County Consolidated Plan 2021-2025](#)

Grant Funds are administered and monitored through the County’s Community & Economic Development Department. All applications must comply with the HUD Community Development Block Grant Program Federal Regulations, see 24 CFR Part 570 for the CDBG Program; and all relevant federal, state, and local laws. These funds will be awarded to participating cities and nonprofit organizations which provide services to low-and moderate income (LMI) persons living in Davis County.
