- 2 The completion of at least 200 consecutive days of active duty military service outside the state in an active component of the US Armed Forces or a reserve component of the US Armed Forces and that began in the prior year, if those days of active military service outside the state in the prior year were not counted as qualifying active duty military service for the prior year. Utah Code Ann. §59-2-1104(1)(i)
